



Harris County 2025: Sports & Entertainment July 2025

The Hobby School of Public Affairs at the University of Houston conducted a survey of Harris County registered voters to assess their preferences and opinions about a wide range of salient local issues and public officials. The survey was fielded between July 9 and July 18, 2025 by contacting Harris County registered voters via SMS text messages through which they were directed to an online survey platform with the option to answer the survey in English or Spanish. Representative of the Harris County population of registered voters, the analysis population of 2,300 has a margin of error of +/- 2.04%. Within this overall Harris County survey population, representative samples also were collected for Harris County's four county commissioner precincts, with analysis populations of 550 for Precincts 2, 3, and 4 (margin of error of +/-4.18%) and of 650 for Precinct 1 (+/- 3.84%).

This study includes four reports. The first report examined the Harris County registered voters' opinions on the direction in which the county is headed, the most important problems facing Harris County, the impact of factors on the quality of life in their neighborhood, the job performance of county elected officials, and on potential candidates for the position of Harris County Judge. This report gauges the level of enthusiasm among Harris County registered voters for a destination theme park and for a motor speedway being built in Harris County and obtaining a Women's National Basketball Association (WNBA) team and a National Hockey League (NHL) team as well as their level of support for using public funds to renovate NRG Stadium and the Astrodome. A third report will assess Harris County registered voters' concerns about the potential impact of severe summer weather as well as their evaluation of CenterPoint's efforts to harden the region's electrical grid over the past year. An additional report utilized a unique survey population drawn from this larger survey project to analyze the candidate evaluations and vote intention of Harris County registered voters who are likely to vote in the November 2025 Texas Congressional District 18 Special Election.

EXECUTIVE SUMMARY

Roughly three-quarters of Harris County voters believe that Harris County should fund at least a portion of the cost of renovating NRG Stadium. 26% of Harris County voters believe that the county should pay between 21% and 40% of the renovation costs for NRG Stadium while 25% believe the county should pay for between 1% and 20%, and 23% believe the county should pay more than 40% of the cost of renovating NRG Stadium. One quarter (26%) believe the county should pay nothing.

An overwhelming majority of Harris County registered voters have a favorable opinion of NRG Stadiums' two tenants, with 81% having a favorable opinion of the Houston Livestock Show & Rodeo and 73% having a favorable opinion of the Houston Texans.

Only 12% and 18% of registered voters have an unfavorable opinion of the Houston Livestock Show & Rodeo and Houston Texans, respectively, with the remaining 7% and 9% not knowing enough about the organizations to have an opinion.

62% of Harris County registered voters support Harris County using public funds as part of a public-private partnership to help pay to renovate the Astrodome into an entertainment venue, while 38% oppose this initiative.

68% of Harris County registered voters are enthusiastic about a destination theme park resort being opened in Houston, while 32% are not enthusiastic.

36% of Harris County registered voters (and 50% of those with children under 18) say they would visit a destination theme park resort more than once a year, 25% would visit once a year, 21% would visit less than once a year (but would visit), and 18% would never visit.

48% of Harris County registered voters are enthusiastic about a major motor speedway designed to host NASCAR, Formula I and IndyCar races being opened in Houston, while 52% are not enthusiastic.

64% of Harris County registered voters are enthusiastic about Houston getting a Women's National Basketball Association (WNBA) team, while 36% are not enthusiastic.

61% of Harris County registered voters are enthusiastic about Houston getting a National Hockey League (NHL) team, while 39% are not enthusiastic.

75% of Harris County registered voters are enthusiastic about Houston hosting seven Men's Soccer World Cup games at NRG Stadium in the summer of 2026, while 25% are not enthusiastic.

SURVEY POPULATION DEMOGRAPHICS

White Harris County registered voters account for 39% of this survey population, Latino registered voters for 30%, Black registered voters for 22%, Asian American registered voters for 5%, and others for 4%. Women represent 52% of this population and men 48%. Almost one-third (30%) of the population is between the ages of 18 and 34, 34% between the ages of 35 and 54, and 36% are age 55 and older. Half of the respondents (50%) have a four-year college degree, while half (50%) do not. A little more than one-fifth of these Harris County registered voters (22%) report that a child under the age of 18 lives in their home, while 78% report that no child under 18 lives in their home. Democrats account for 45% of this population, Republicans for 33% and Independents for 15%, with 7% either unsure of their partisan identification or identifying with another party or group.

FUNDING THE RENOVATION OF NRG STADIUM

The survey respondents were asked the following question related to public funding of the renovation of NRG Stadium:

"Harris County owned NRG Stadium (home of the NFL's Houston Texans and the Houston Livestock Show & Rodeo) is in need of renovations costing between \$1 billion and \$2 billion. When NRG Stadium was built, public funding paid for 60% of the cost of the stadium and the Houston Texans paid for 40%. Which of the numbers below comes closest to the proportion of the renovation cost that you think should be publicly funded by Harris County?" The response options were: 0%, 1-20%, 21-40%, 41-60%, 61-80%, 80-100%, and unsure.

Figure 1 provides the distribution of the responses of these Harris County registered voters (the small proportion who answered unsure are excluded). A quarter (26%) of Harris County registered voters believe that Harris County should not provide any funding for the renovation of NRG Stadium, another quarter (25%) believe that Harris County should provide funding in the 1% to 20% range, and another quarter (26%) believe that Harris County should provide funding in the 21% to 40% range. The remaining quarter (23%) of Harris County registered voters is split among those who believe the county should provide 41-60% (18%), 61-80% (3%), and 80-100% (2%) of the funding.





Table 1 provides the distribution of the proportion of Harris County residents who believe that Harris County should provide 0%, 1-20%, 21-40%, 41-60%, and 61-100% of the funding to renovate NRG Stadium, broken down by gender, ethnicity/race, age, education, the presence of children under 18 in the home, partisanship, and the county commissioner precinct in which the registered voter resides.

Overall, there are not any significant socio-demographic differences in the distribution of the preferences for the proportion of the NRG Stadium renovation cost that should be publicly funded by Harris County.

Figure 2 provides the proportion of Harris County registered voters with a favorable and unfavorable opinion of the Houston Livestock Show & Rodeo (HLSR) and of the Houston Texans, the main tenants of NRG Stadium, along with the proportion of registered voters who do not know enough about the Houston Livestock Show & Rodeo and about the Texans to have an opinion about the organization, one way or another.



More than four out of five (81%) of Harris County registered voters have a favorable opinion of the Houston Livestock Show & Radio, while 12% have an unfavorable opinion and 7% do not know enough about the HLSR to have an opinion. Almost three out of four (73%) Harris County registered voters have a favorable opinion of the Houston Texans, while 18% have an unfavorable opinion and 9% don't know enough about the Texans to have an opinion.

Table 2 provides the proportion of Harris County registered voters with a favorable and unfavorable opinion of the Houston Livestock Show & Radio and of the Houston Texans, broken down by gender, ethnicity/race, age, education, the presence of children under 18 in the home, partisanship, and the county commissioner precinct in which the registered voter resides.

Overall, there are no significant socio-demographic differences in the proportion of Harris County registered voters who have a favorable and unfavorable opinion of the Houston Livestock Show & Radio and of the Houston Texans, with one minor exception. The exception is that Harris County registered voters who are 55 and older (79%) are significantly more likely than those under the age of 35 (65%) to have a favorable opinion of the Houston Texans, although, it is important to note that almost two-thirds of these younger voters have a favorable opinion of the Texans.

A PUBLIC-PRIVATE PARTNERSHIP TO RENOVATE THE ASTRODOME

The survey respondents were asked the following question related to support for or opposition to a public-private partnership to renovate the Astrodome:

"2002 was the last year an event was held at the Astrodome. To what extent would you support or oppose Harris County using public funds as part of a public-private partnership to help pay to renovate the Astrodome for use as an entertainment venue with additional space for offices, lodging, retail, and restaurants?"

Figure 3 reveals that 62% of Harris County registered voters support Harris County using public funds as part of a public-private partnership to help pay to renovate the Astrodome for use an entertainment venue, while 38% oppose this initiative.




Table 3 provides the proportion of Harris County registered voters who support and oppose a public-private partnership to help pay to renovate the Astrodome, broken down by gender, ethnicity/race, age, education, the presence of children under 18 in the home, partisanship, and the county commissioner precinct in which the registered voter resides.

Overall, there are not any significant socio-demographic differences in the proportion of Harris County registered voters who support and oppose a public-private partnership to help pay for the renovation of the Astrodome, with one exception. Harris County Democrats are significantly more likely than Harris County Republicans to support this public-private partnership (69% vs. 55%) and are significantly less likely to oppose it (31% vs. 45%). That said, the public-private partnership still enjoys the support of a majority of Harris County Republicans.

THE OPENING OF A DESTINATION THEME PARK RESORT IN HOUSTON

The survey respondents were asked the following question related to their level of enthusiasm regarding a destination theme park resort being opened in Houston:

"How enthusiastic would you be about a destination theme park, water park and resort for all ages like Disney World or Universal Studios being opened in Houston?"

Figure 4 reveals that more than two-thirds (68%) of Harris County registered voters are enthusiastic about a destination theme park resort being opened in Houston, while less than one-third (32%) are not enthusiastic about a theme park being opened.




Table 4 provides the proportion of Harris County registered voters who are enthusiastic and who are not enthusiastic about a destination theme park resort being opened in Houston, broken down by gender, ethnicity/race, age, education, the presence of children under 18 in the home, partisanship, and the county commissioner precinct in which the registered voter resides.

With three exceptions, there are no significant socio-demographic differences in the proportion of Harris County registered voters who are enthusiastic about a destination theme park resort being opened in Houston. The first exception is that Black (79%) and, to a lesser extent, Latino (72%) Harris County registered voters are more enthusiastic than White (61%) registered voters about the opening of a theme park, although more than three-fifths of White voters are enthusiastic. Second, Democrats (73%) are significantly more enthusiastic than Republicans (61%) about the opening of a theme park, although more than three-fifths of Republicans are enthusiastic. Third, registered voters with children under 18 living with them (75%) are significantly more likely than those without children under 18 in their home (65%) to be enthusiastic about the opening of a theme park, although almost two-thirds of voters without children in their home are enthusiastic.

The survey respondents were also asked how often they would visit a new destination theme park resort were one to open in Houston later this decade. Figure 5 reveals that 36% would visit the theme park resort more than once a year, 25% would visit once a year, 21% would visit less than once a year (but would visit), and 18% would never visit the theme park.




Table 5 provides the distribution of the frequency at which Harris County registered voters who would visit a destination theme park resort, broken down by gender, ethnicity/race, age, education, the presence of children under 18 in the home, partisanship, and the county commissioner precinct in which the registered voter resides.

With two main exceptions, there are not any significant socio-demographic differences in the frequency at which Harris County registered voters would visit a destination theme park resort were one to open later this decade. The first exception is that registered voters with children under the age of 18 in their home (50%) are significantly more likely than those without children at home (30%) to report that they would visit the theme park more than once a year. Second, Black registered voters (48%), and to a lesser extent Latino registered voters (41%), are significantly more likely than White registered voters (27%) to report that they would visit the theme park more than once a year.

THE OPENING OF A MOTOR SPEEDWAY IN HOUSTON

The survey respondents were asked the following question related to their level of enthusiasm regarding a motor speedway being opened in Houston:

"How enthusiastic would you be about a major motor speedway designed to host NASCAR, Formula 1, IndyCar and other racing events being opened in Houston?"

Figure 6 reveals that Harris County registered voters are evenly divided in their position vis-à-vis a major motor speedway being opened in Houston, with 48% enthusiastic about the prospect of a speedway being opened and 52% not enthusiastic.




Table 6 provides the proportion of Harris County registered voters who are enthusiastic and not enthusiastic about a major motor speedway being opened in Houston, broken down by gender, ethnicity/race, age, education, the presence of children under 18 in the home, partisanship, and the county commissioner precinct in which the registered voter resides.

With three main exceptions, there are not any significant socio-demographic differences in the proportion of Harris County registered voters who are enthusiastic and not enthusiastic about a major motor speedway being opened in Houston. The first exception is that men (53%) are significantly more likely than women (44%) to be enthusiastic about a speedway being opened. Second families with children under the age of 18 in the home (56%) are significantly more likely than those without children under 18 at home (45%) to be enthusiastic about a speedway being opened. Third, Republicans (56%) are significantly more likely than Democrats (42%) to be enthusiastic about a speedway being opened.

THE ESTABLISHMENT OF A WNBA TEAM AND OF AN NHL TEAM IN HOUSTON

The survey respondents were asked how enthusiastic they would be about Houston getting a Women's National Basketball Association (WNBA) team and about Houston getting a National Hockey League (NHL) team.

Figure 7 highlights that 64% of Harris County registered voters are enthusiastic about Houston obtaining a WNBA team while 36% are not enthusiastic. Similarly, 61% of Harris County registered voters are enthusiastic about Houston obtaining an NHL team while 39% are not enthusiastic.




Table 7 provides the proportion of Harris County registered voters who are enthusiastic and not enthusiastic about Houston obtaining a WNBA team and an NHL team, broken down by gender, ethnicity/race, age, education, the presence of children under 18 in the home, partisanship, and the county commissioner precinct in which the registered voter resides.

There are strong gender, ethnic/racial, partisan and county commissioner precinct differences in enthusiasm among Harris County registered voters about Houston obtaining a WNBA team. First, women (76%) are significantly more likely than men (52%) to be enthusiastic. Second, Black registered voters (82%) are significantly more likely than Latino (63%) and White (57%) registered voters to be enthusiastic. Third, Democrats (80%) are significantly more likely than Republicans (38%) to be enthusiastic. Fourth, registered voters in Harris County Commissioner Precinct 1 (71%) are significantly more likely than registered voters in the other three Harris County Commissioner Precincts to be enthusiastic.

In contrast to the case for a WNBA team, there are no noteworthy socio-demographic differences in enthusiasm among Harris County registered voters for Houston obtaining an NHL team.

THE 2026 WORLD CUP GAMES BEING HOSTED IN HOUSTON AT NRG STADIUM

The survey respondents were asked how enthusiastic they are about Houston hosting seven FIFA Men's Soccer World Cup games in the summer of 2026 at NRG Stadium.

Figure 8 reveals that 75% of Harris County registered voters are enthusiastic about Houston hosting seven 2026 World Cup games, while 25% are not enthusiastic.




Table 8 provides the proportion of Harris County registered voters who are enthusiastic and not enthusiastic about Houston hosting seven World Cup games in the summer of 2026, broken down by gender, ethnicity/race, age, education, the presence of children under 18 in the home, partisanship, and the county commissioner precinct in which the registered voter resides.

With two main exceptions, there are not any significant socio-demographic differences in the proportion of Harris County registered voters who are enthusiastic (and not enthusiastic) about Houston hosting seven World Cup games in the summer of 2026. The first exception is that Latino registered voters (84%) are significantly more likely than White registered voters (69%) to be enthusiastic, although it is important to note that more than two-thirds of White voters are enthusiastic. Second, Democrats (79%) are significantly more likely than Republicans (69%) to be enthusiastic, although it is once again important to note that more than two-thirds of Republicans are enthusiastic.
